## Non-Paper

Basic elements for reconsidering "the Agreement on Principles of Regulation of Georgian-Ossetian conflict" from June 24, 1992

## Objective of the New Agreement

Full-scale political resolution of the conflict in the Tskhinvali Region/South Ossetia and definition of autonomous status of the region within Georgia, on the basis of the approved models of European autonomies.

## Task:

- 1. Elaboration by the Georgian and Russian sides, with the participation of representatives of the Tskhinvali Region/South Ossetia, of a basic mechanism for a full-scale political resolution of the conflict in the Tskhinvali Region/South Ossetia;
- 2. Legal structuring of the given mechanism.

## Principal elements of the Agreement

- 1. To change the existing negotiating format (Joint Control Commission), in order to facilitate a direct bilateral dialogue between the conflicting sides; to define the renewed format of JCC involving the Georgian and South Ossetian sides, with the participation of the Russians Federation, US, European Union and OSCE in the capacity of mediators/ guarantors of the agreements reached;
- 2. As a transitional stage in the process of changing the form and contents of the peace operation in the Tskhinvali region/South Ossetia, to replace the existing format of the joint forces (consisting of Russian-Georgian-North Ossetian? battalions) by the peacekeeping contingent of the Russian Federation and Georgia. To define the entire territory of the Tskhinvali region as a zone of responsibility of peacekeeping forces. To define as transitional stages to be completed by the end of 2006:
- Completion of the process of full demilitarization of the region (carried out by the Georgian-Russian peacekeeping contingent) under the OSCE monitoring;
- Georgian-Russian joint peacekeeping forces, upon completion of the demilitarization of the region, will delegate their functions to the Joint Georgian-Ossetian Centre for coordination between the law enforcement facilities of the sides, with a possible involvement of an international police component, including participation of representatives from the Russian Federation;
- 3. With the goal of elaborating further and implementing a set of comprehensive measures, as well as intensifying confidence building measures between the sides, to continue the process of rehabilitation of economy in the Tskhinvali region/South Ossetia, with a broader involvement in this process of potential donors and the sides concerned. In parallel with the process of rehabilitation of economy in the Tskhinvali region/ South Ossetia, to define the region's status within Georgia, on the basis of the approved models of European autonomies.
