Joint Committee Meeting with the Federal Assembly's International Affairs Committees on 21 December 2005 in Moscow

RESUMÉ

"Back on track with strategic partnership" - that is how the Deputy Minister for Foreign Affairs, Mr Grushko, resumed the state of art of EU-Russia relations.

The regular meetings at the level of the Foreign Affairs Committee, the Parliamentary Cooperation Committee meetings and its Working Groups and the Federal Government's recent meetings in Brussels (6 December 2005) with the European Commission have created a network of relations which is functioning and gaining importance in competition to the bilateral links Russia is strongly advocating with certain Member States.

The focus of interest throughout the different meetings was on

- progress in the four common spaces
- Estonia and Latvia border agreements
- the situation of Russians in the Kaliningrad region
- the Russian speaking population of Latvia
- the future of relations after the expiration of the PCA in 2007.

The EP delegation added to this traditional bundle of topics some of more current importance:

- Russian sales of anti-aircraft missiles to Iran
- Russian vote in the UN Security Council on Iran
- the Baltic Sea gas pipeline
- the frozen conflicts (Abkhazia, Ossetia, Transnistria)
- the situation of "in-between"-countries, such as Ukraine
- political events in Belarus
- the NGO bill
- security cooperation EU-Russia.

Having discussed the above mentioned topics, it was agreed that Mr Tulalev would forward on Mr Brok's request, a proposal for practical measures in favour of the Kaliningrad region to be discussed at a meeting to be organised in Brussels following the upcoming PCC meeting. On this occasion, Governor Boos should be invited to attend.

Mrs Svetlana Shirnova raised the issue of the EP resolution on the situation of the Mari and Finno-Ugursk minorities, and repeated the invitation to MEPs to attend meetings with their representatives in the region.

In conclusion, after several exchanges of views, a practical proposal was agreed to work towards a simple ratification of the Estonia-RF border agreement by simple vote without any additions, to come into force as soon as the respective Parliaments had adopted it.

Mr Kosachev proposed that an EP resolution should address Estonia, Latvia and the RF, inviting them to ratify the Border agreements, including only technical annexes, without the addition of further resolutions.

During the press conference of Mr Brok, Mr Ilves, Mr Kosachev and Mr Magelov at the State Duma, the NGO bill was adopted in second reading in the Plenary.

EC representatives were satisfied with the modifications obtained.
